

## Miss Kanekalon 2018 Full Terms and Conditions

Submission of application to Miss Kanekalon 2018 will automatically prove that I, as well as my teaming hair stylist have read and agreed to all the Terms and Conditions stated below:

### General points

1. I understand the pageant I am entering for is *Miss Kanekalon Pageant 2018*, which is only for natural and young single ladies between the ages of 18-25 years old (as at 14<sup>th</sup> July 2018) and of African nationality, currently residing in Nigeria or Ghana.
2. I understand that the event is being organized by KANEKA Corporation, Japan, manufacturers of KANEKALON hair fiber with the theme:” Crowning your African Beauty”. Such being the case, I must be a KANEKALON hair attachment user and all physical selection process requires me to wear, at my own expense, KANEKALON braids.
3. I understand that the required height for participation is at least 5ft 6 inches tall.
4. I understand that the decisions made by the judges and KANEKA corporation will be final and binding. Therefore, no disputes in this regard will be entertained.
5. I understand that, if I fail to comply with the entry procedure, I as a participant will be penalized with disqualification and possible lawsuit for denting the image of the Miss Kanekalon 2018 Pageant title.
6. I agree that I have made all the necessary disclosures and have answered all of the questions on the application form completely, correctly and accurately and I confirm I have not misled or attempted to mislead the organizers of Miss Kanekalon 2018 Pageant at any given process during the course of selection of Miss Kanekalon 2018.
7. I understand that if any of the information I have given is false, the organizers of Miss Kanekalon 2018 Pageant will be entitled to exclude me from the selection process and I will be obligated to refund for the incurring cost.
8. I understand that I am expected to conduct myself in a proper manner during the course of my stay for Miss Kanekalon 2018 Pageant. And that I am expected to be charming and pro-active, with high morales and respect towards organizers and peers.
9. I pledge that I accept these rules and I have no legal obligations which conflict with the making and signing of this Terms and Conditions in accordance with the rules.
10. I understand that due to the ethical and subsequent requirements for winners and contestants with health challenges, tattoo, birth marks, scars or criminal records (applicant herself as well as her family should be free from any criminal records) are not eligible for the competition and submission of application will automatically prove that I do not have any of the conditions listed here.
11. I understand that I must attend the physical selection process of Miss Kanekalon 2018 at

given dates and venues at my own cost except in the event of being selected as one of the top 20 FINALISTS for the FINALS in Lagos to which my teaming stylist is also required to attend.

12. I understand that the process and duties when selected as Miss Kanekalon 2018 requires me to be fluent in English language.
13. I understand that my least academic qualification should be secondary school leaving certificate.
14. I understand that I must provide a genuine birth certificate or affidavit signed by a notary public when called upon during the process of Miss Kanekalon 2018.

### **Stylist**

1. I understand that I am required to team up with a hair stylist who works at or owns a legitimate hair salon that will fix or weave my hair with KANEKALON braids throughout the required selection steps of Miss Kanekalon 2018 at my own expense and I warrant that completing and returning my application will automatically means that I have gotten the consent of my team of hair stylist/hair salon with regards to the Terms and Conditions stated herein.
2. I and my team of hair stylist/hair salon understand that being selected as one of the 20 FINALISTS, requires both myself and my stylist to be called upon on various occasions including and not limiting to join a Beauty camp, style hair etc. The occasion may require either both or only the FINALIST (contestant) to attend.
3. I and my team of hair stylist/hair salon understand that we are both required to attend the Miss Kanekalon 2018 FINALS on 14<sup>th</sup> July, 2018 as well as the rehearsal holding a day before i.e. on 13<sup>th</sup> July, 2018.
4. I understand that I am solely responsible for the resolution of any dispute, disagreement and/or conflict between my team of hair stylist/hair salon if any arises and in case such dispute, disagreement and/or conflict with the process of Miss Kanekalon 2018 occurs, I could be disqualified and slam with a possible lawsuit for denting the image and process of Miss Kanekalon 2018.
5. I understand that my team stylist also receives prizes that will contribute to his or her business; in addition to introductions that will boost his or her business.

### **Duties when selected**

1. I understand that when I am selected as the Winner or as 1<sup>st</sup> Runner up, or 2<sup>nd</sup> Runner of Miss Kanekalon 2018, I am not permitted to appear in any other beauty or hair care related advertising communication activities and any beauty contests in Nigeria or Ghana and in any other country in the world. Any participation in any event or offers such as modeling, acting, advertisement, public appearances, even if it is not related to beauty or hair care product,

brand or companies whether paid or unpaid, should all be carried out in consultation with the organizers of the pageant from 14<sup>th</sup> July 2018 till 31<sup>st</sup> August 2019.

2. I understand that if I am the winner or 1<sup>st</sup>, 2<sup>nd</sup> Runner-up of Miss Kanekalon 2018 Pageant, I will have to remain two more days in the host place for previously arranged commitments for the winner, if so requested by KANEKA Corporation and/or Agency.

3. I understand when I am selected as the Winner or 1st Runner up, 2<sup>nd</sup> Runner up of Miss Kanekalon 2018, that from the date of the FINALS i.e. 14<sup>th</sup> July 2018 to the end of my tenure i.e. 31<sup>st</sup> August 2019, I will be bound by the Terms and Conditions herein and I will execute a contract that I will have the obligations to appear for advertising shoots and events to be designated by KANEKA Corporation, Japan, through its appointed agency that there is no restriction in the terms of use of my image such as period, territory and media and that I am not entitled to any fee except the opportunity of representing the brand through appearances on radio and television as well as at events. I also get to travel and the chance to rub shoulders with the hair and beauty industry team leaders.

### **Usage right**

1. I accept that organizers of Miss Kanekalon Pageant should manage and use my image, video and contents in interviews and in the application form amongst any other forms and the materials to be reproduced, modified, adapted, published, translated, create derivative works of and distribute such materials or incorporate such materials into any form, medium, or technology now known or later developed without any restriction in the period, territory and media of use.
2. I understand that I cannot use my image as Miss Kanekalon 2018 Pageant participant, logos or slogans for any parade, event or programme without the consent of the organizers of Miss Kanekalon 2018 Pageant.

### **Conduct and Others**

1. I understand that the organizers of *Miss Kanekalon 2018 Pageant* will provide the 20 FINALISTS and Teaming Stylists with a shared hotel room (with exceptional cases decided by organizers of *Miss Kanekalon 2018 Pageant*), meals, and transportation for the official FINALS on 14<sup>th</sup> July 2018.
2. I understand that *Miss Kanekalon 2018 Pageant* is a hair, beauty and talent competition. With that in mind I commit to be in good physical shape. In case of not being in good shape for the event, the *Miss Kanekalon Pageant's* organizers has the right to disqualify the participant at any time during the competition.
3. I understand that the *Miss Kanekalon 2018 Pageant* title belongs to Kaneka Corporation, Japan. In that regard, I can never use the title for personal profit with any company or agency without written authorization.

4. I understand that I have to follow and respect all the timelines, deliver all accurate and honest documentation and all other responsibilities of the event. If I do not follow any of these rules I should be disqualified as a participant or 20 FINALISTS, crowned winner, 1<sup>st</sup> or 2<sup>nd</sup> runner up.
5. I understand that the organizer of Miss Kanekalon 2018 Pageant is not responsible for any personal belongings. In this sense I understand I cannot complain in the case of any of my personal belonging being missing.
6. I understand and agree that the organizer of *Miss Kanekalon 2018 Pageant* is not responsible for any accident or injury during the event.
